Item 9. Other Events

Further to our disclosure dated 10 November 2015 on the announcement by Vista Land & Lifescapes, Inc. of its acquisition (the "STR Acquisition") of approximately 88.25% of the outstanding common capital stock of Starmalls, Inc. ("Starmalls" or "STR") from Fine Properties Inc., Althorp Holdings, Inc., Manuela Corporation, Manuel Paolo A. Villar, and Manuel B. Villar, Jr. (collectively, the "Fine Group"), we disclose that VLL has announced today, 22 December 2015, the completion of the first tranche of the STR Acquisition with the crossing from the Fine Group to VLL of a total of 6,692,928,686 common shares representing approximately 79.43% of the total outstanding common capital stock of Starmalls.
